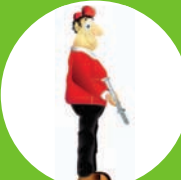


**#10 X 3" COMBO PAN AB TAPPING

- Screws conform to the dimensions of ASME B18.6.3

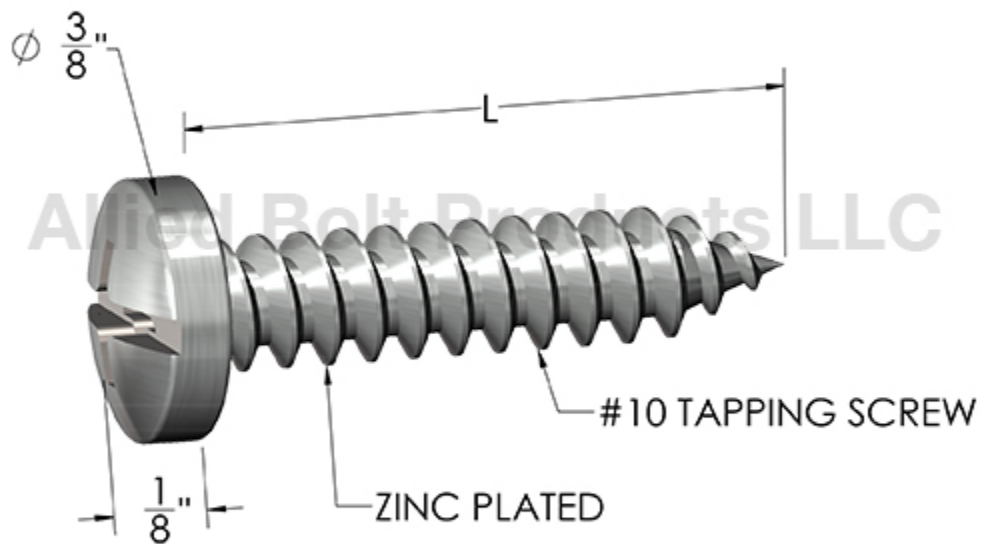
