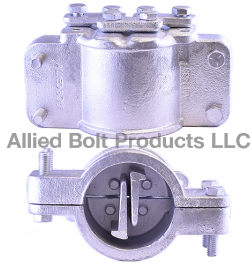

- All components are hot dip galvanized to meet ASTM Specification A153.

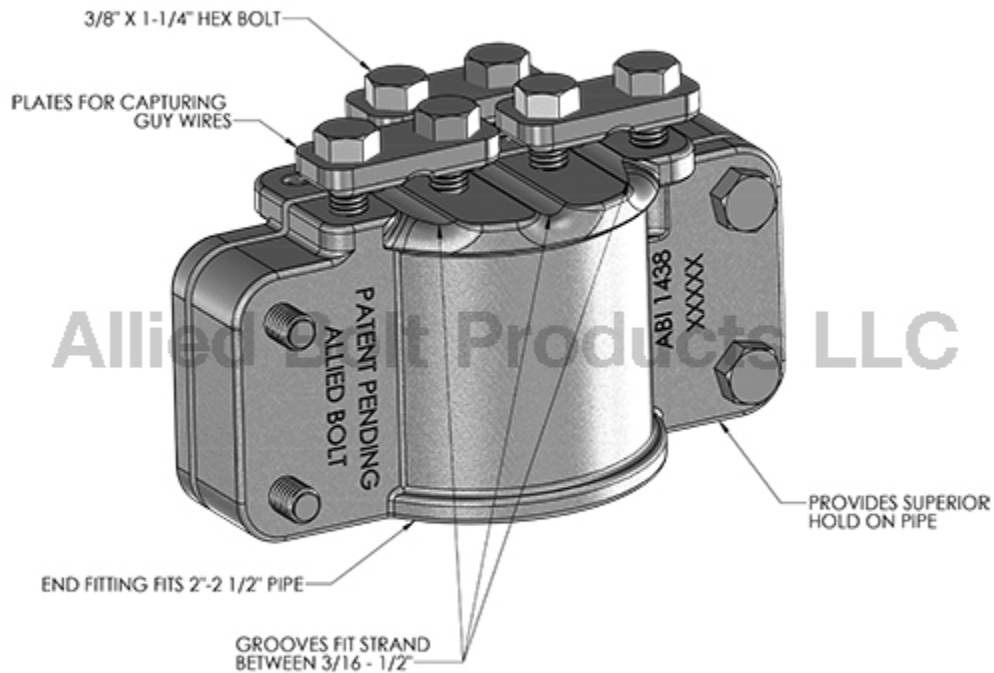
