- Zinc Plating ASTM Specification B633.

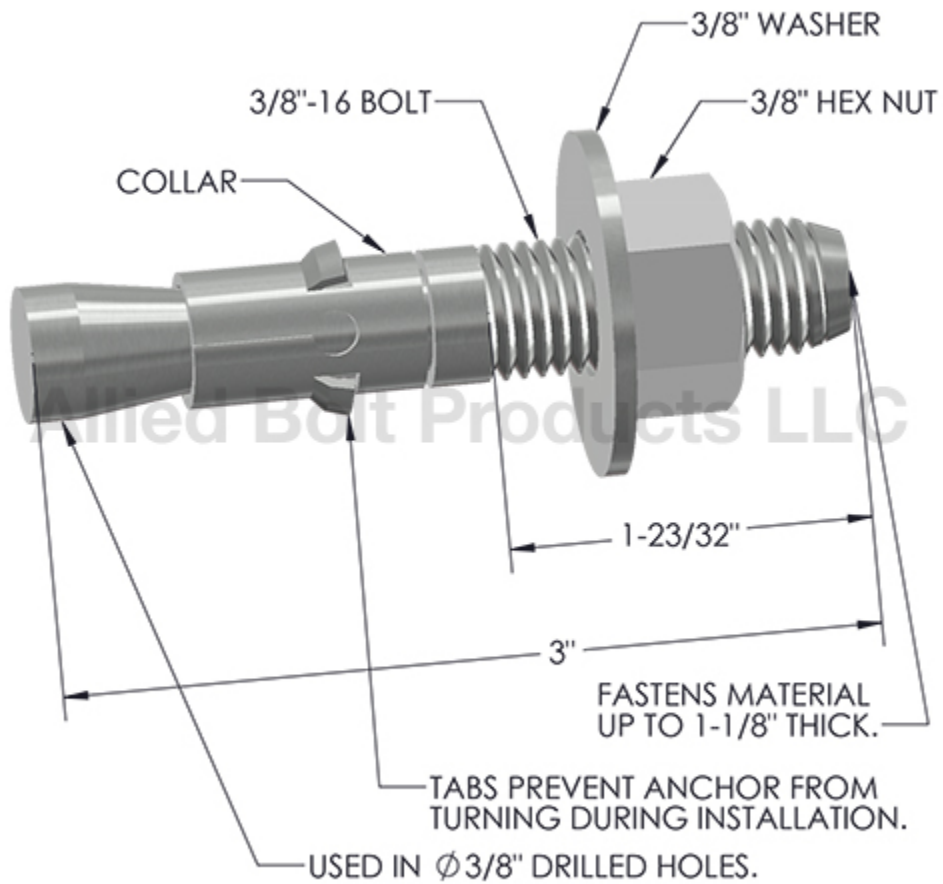
