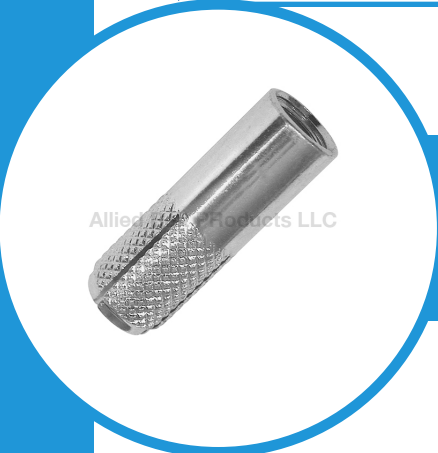

- Tool required for installation.

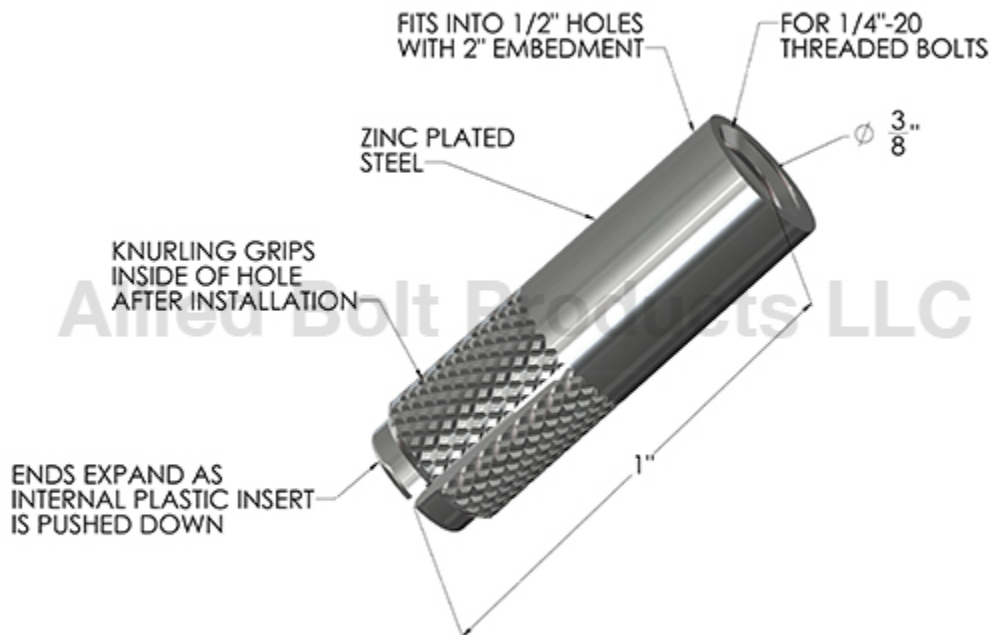
