- Washers conform to the dimensions of ASME B18.21.1

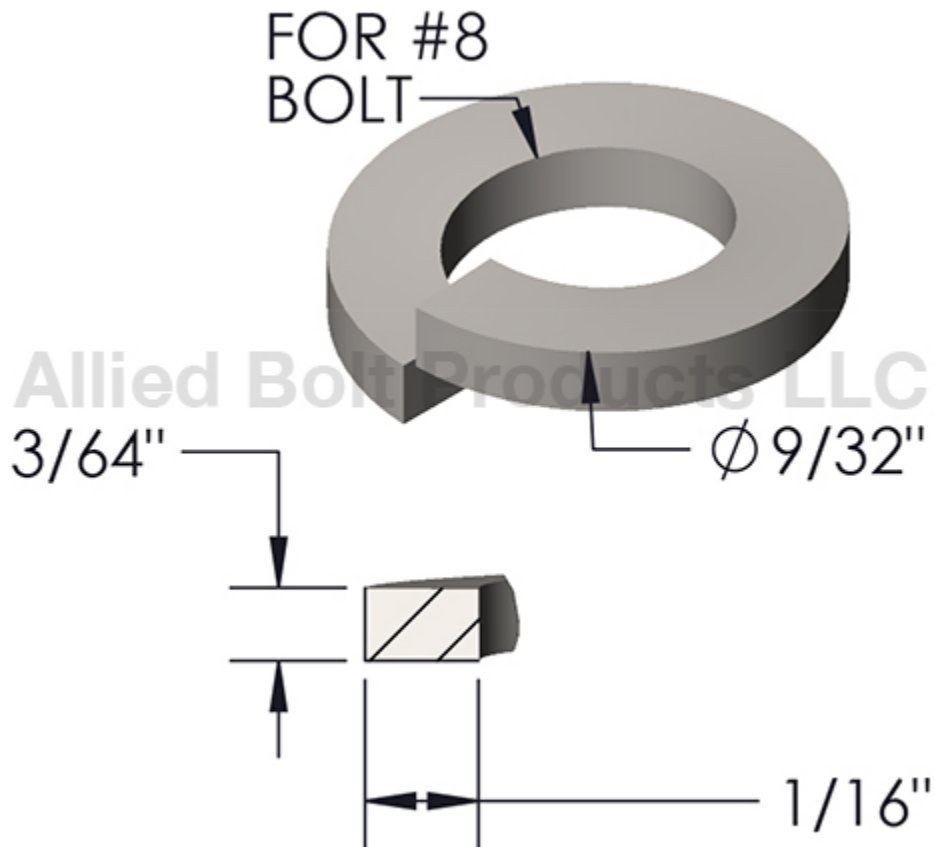
