- Ideal for heavy loads. Accommodates Coaxial Drop Cable up to RG-11 Quad Shield.

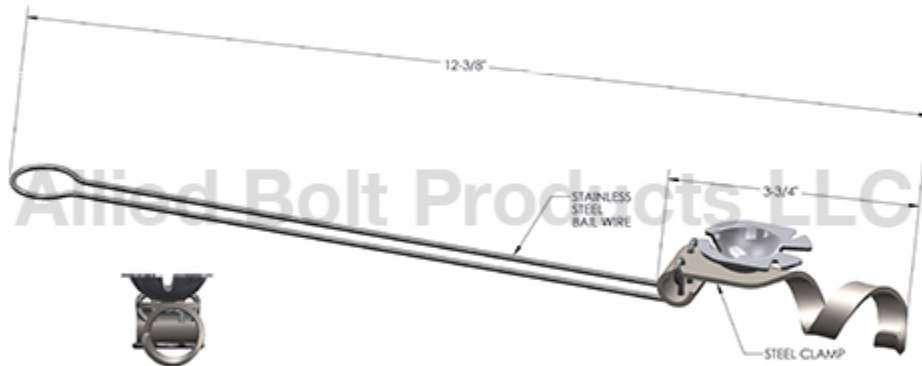
