- UL Listed under file number E211717.

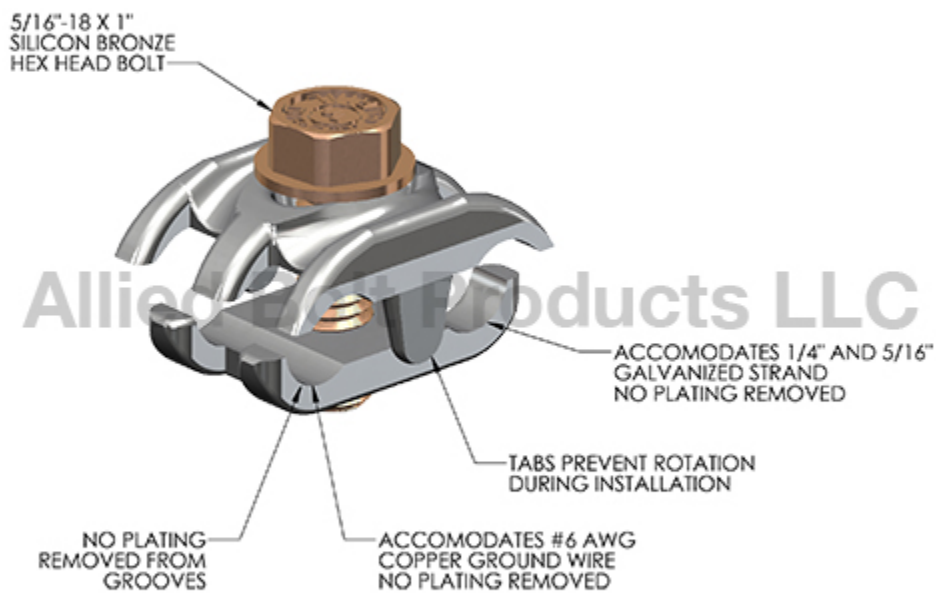
