- The largest conductor accommodated is #2 AWG Stranded. The smallest conductor accommodated is #10 AWG Solid.
- Comprised of a high-strength bronze forging and a 3/8"-16 x 3/4" silicone bronze hex bolt.

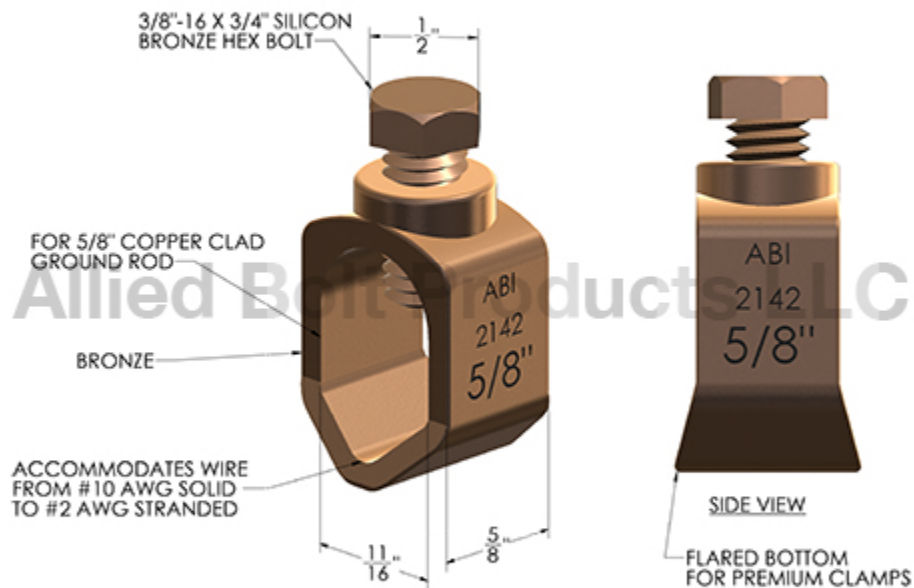
