- Ultimate strength (maximum value at fracture) is 27,000 lbs. at 45°;

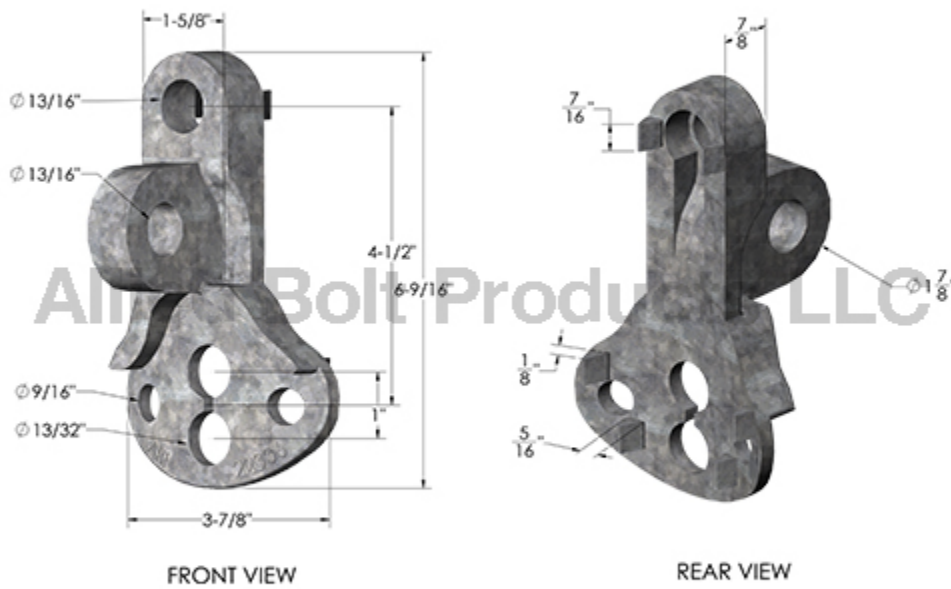
