- Anchor remains securely installed even when bolt is removed.

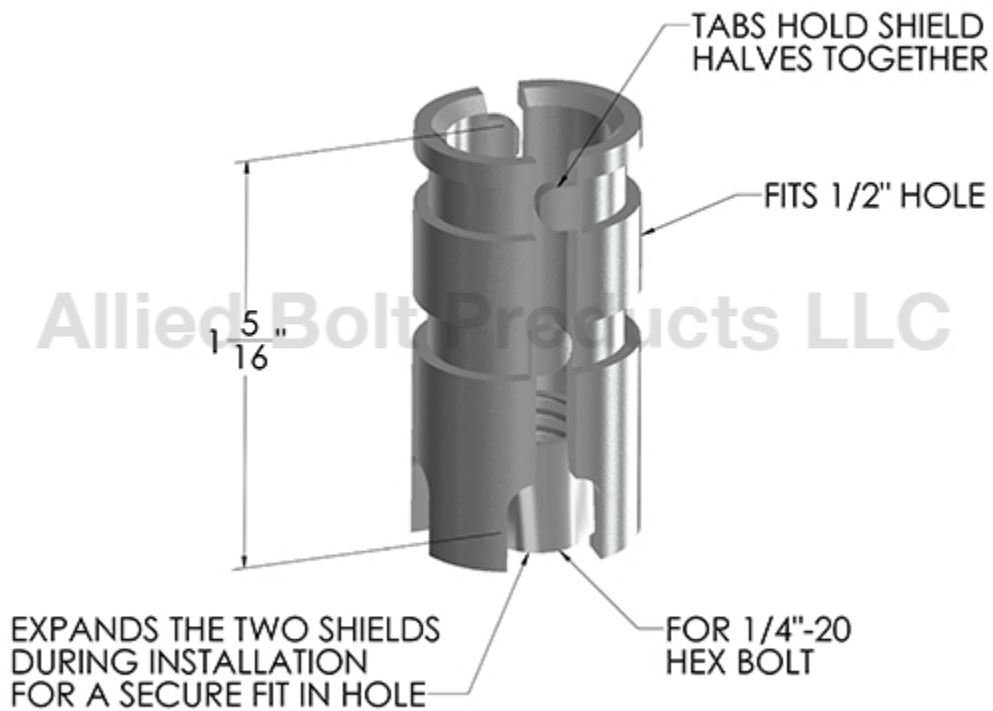
