- Carriage Bolts are full threaded.

- Recommended torque value: 4 ft lb.

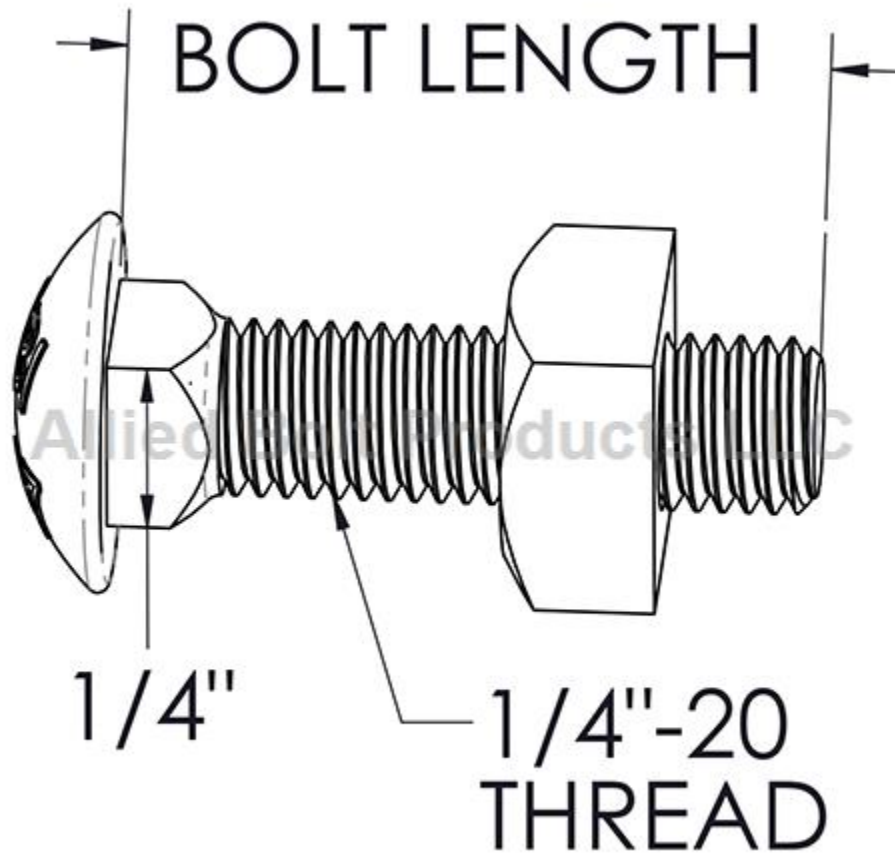
