- Zinc-plated to meet ASTM Specification F1941.

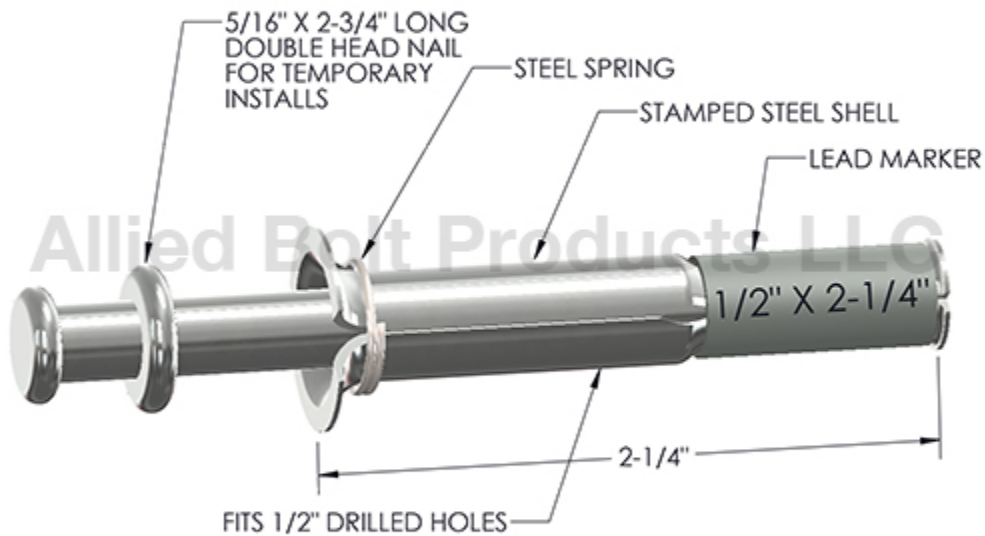
