- Hot dipped galvanized to meet ASTM specification F2329.

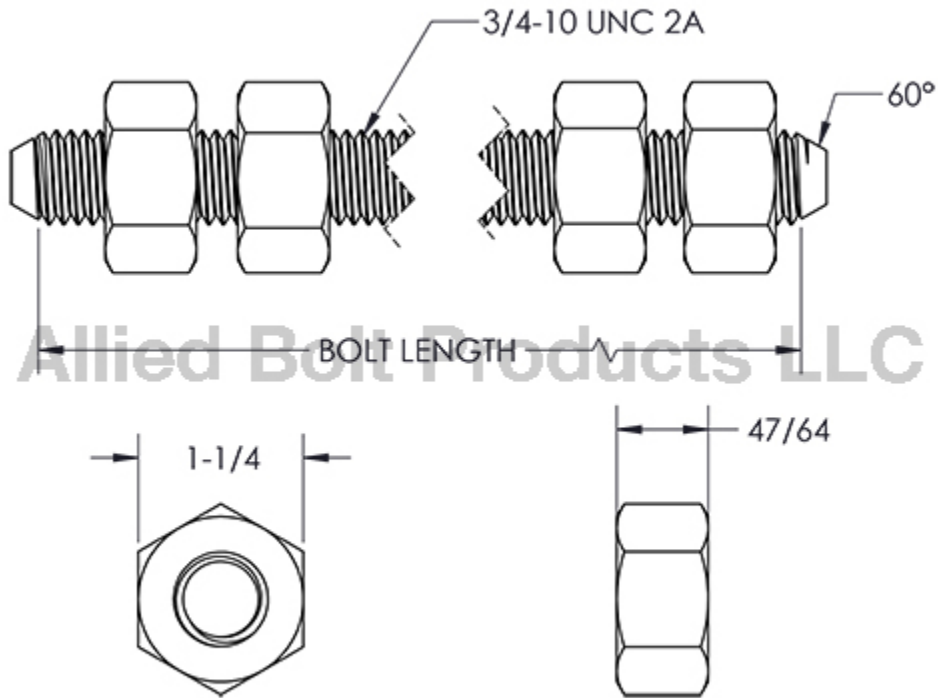
