12" SINGLE SOLID SQUARE HUB HELIX **POWER DRIVEN ANCHOR 1-1/2" HUB** FOR 3/4" & 1" RODS - 8000 FT. LB.

- Installation is performed using a power digger. An anchor wrench fits over the square hub and a torque measurement device is required to determine proper installation.
- Correct installation is achieved only when the anchor is installed using the appropriate torque for the particular soil and anchor type (see reference charts).
- Proper anchor selection depends on the type of soil and guying requirements.
- Installation torque is usually measured using a device connected in series with the wrench, digger, and Kelly Bar during installation.

- Soil Class 3: 33000 lbs (Limited by rod strength)


