- Installation is performed using a power digger. An anchor wrench fits over the square hub and a torque measurement device is required to determine proper installation.
- Correct installation is achieved only when the anchor is installed using the appropriate torque for the particular soil and anchor type.
- Installation torque is usually measured using a device connected in series with the wrench, digger, and Kelley Bar during installation.
- Holding strength per soil class with 3/4" rod:
 - Soil Class 2: 32000 lbs
 - Soil Class 3: 30000 lbs
 - Soil Class 4: 16000 lbs
 - Soil Class 5: 14000 lbs
 - Soil Class 6: 10000 lbs
 - Soil Class 7: 60000 lbs
- Holding strength per soil class with 1" rod:
 - Soil Class 2: 32000 lbs
 - Soil Class 3: 30000 lbs
 - Soil Class 4: 16000 lbs
 - Soil Class 5: 14000 lbs
 - Soil Class 6: 10000 lbs
 - Soil Class 7: 60000 lbs

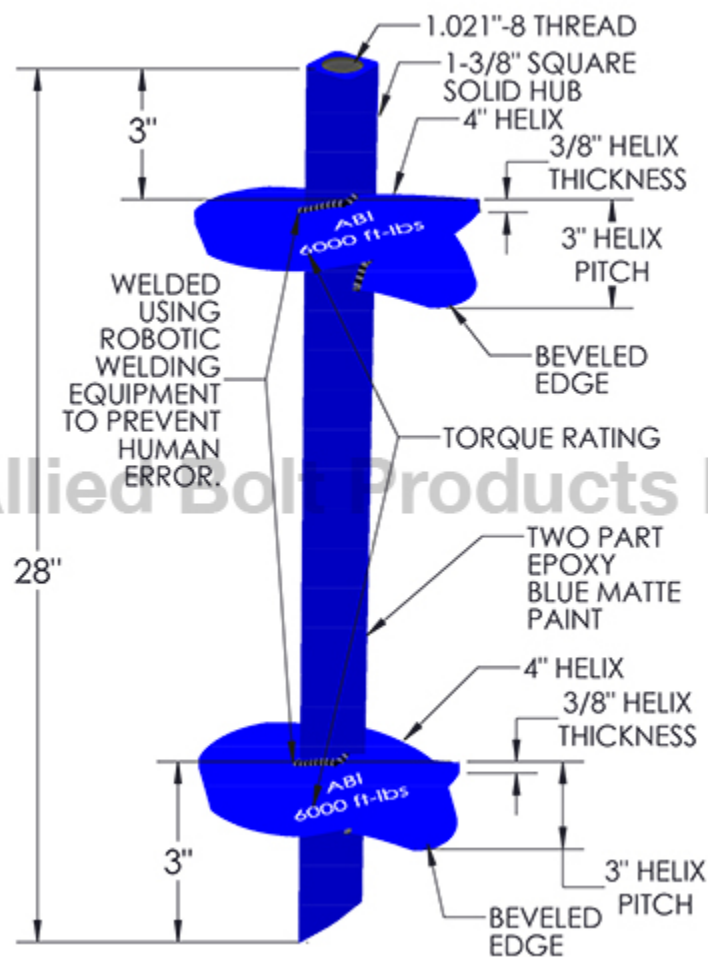
