  - Soil Class 7: 10000 lbs

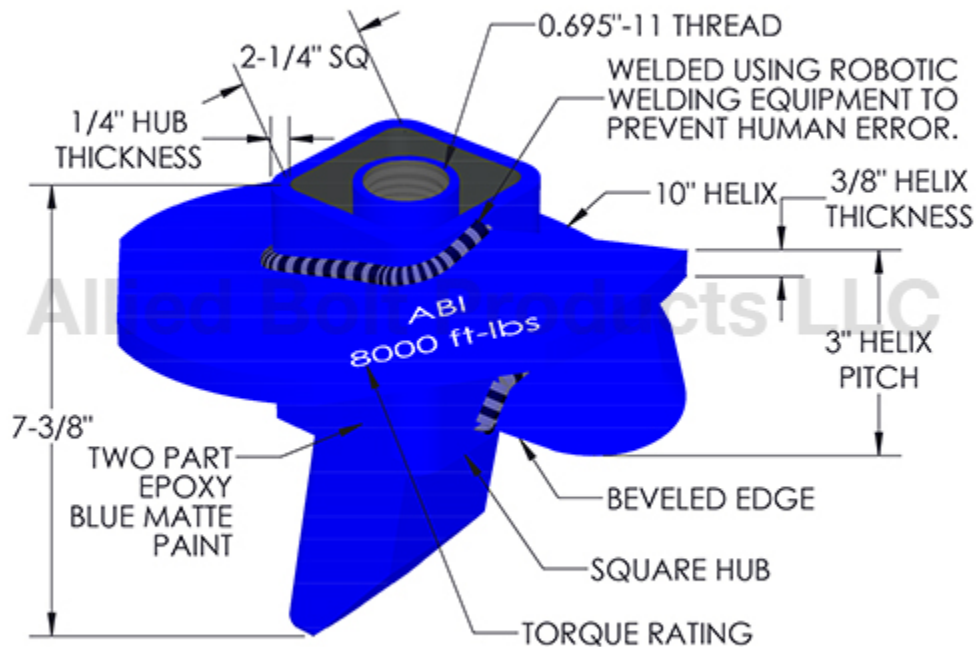
