- Round Shank Multi Helix Anchors are hot dip galvanized to meet ASTM Specification A123.
- Holding strength per soil class:
  - Soil Class 5: 24000 lbs
  - Soil Class 6: 21000 lbs
  - Soil Class 7: 17000 lbs
