- Bolt and nut are hot dip galvanized to meet ASTM Specification A153.
- Attaches to strand ranging from 1/4" (6.6M) to 3/8" (10M).
- Jaws and bracket are stamped from high-strength Aluminum.

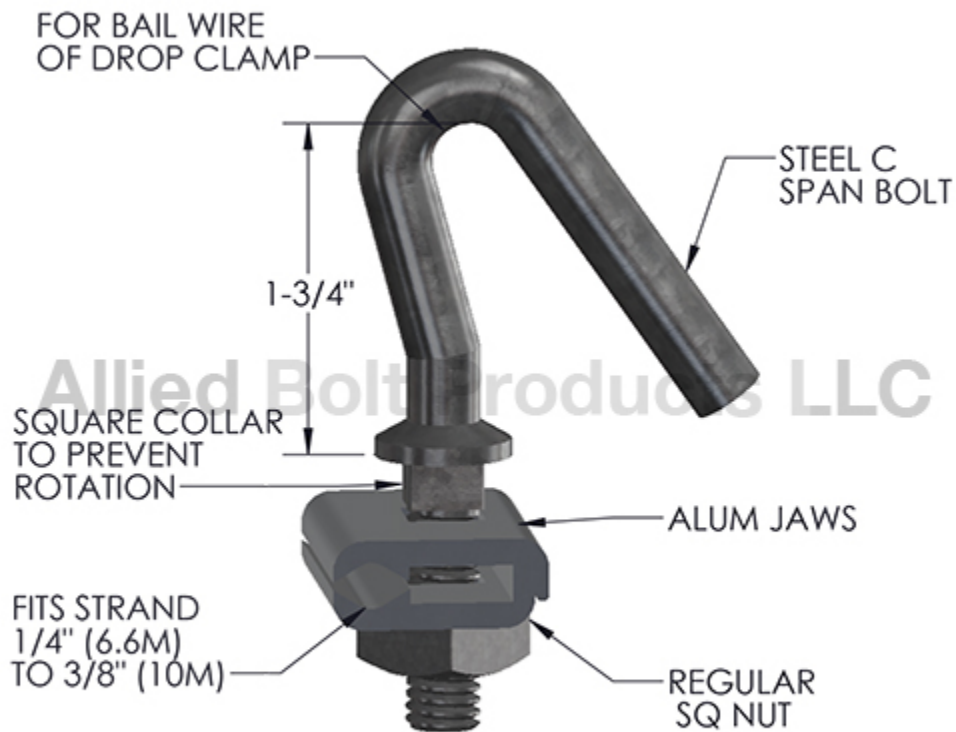
