- Screws conform to the dimensions of ASME B18.6.3

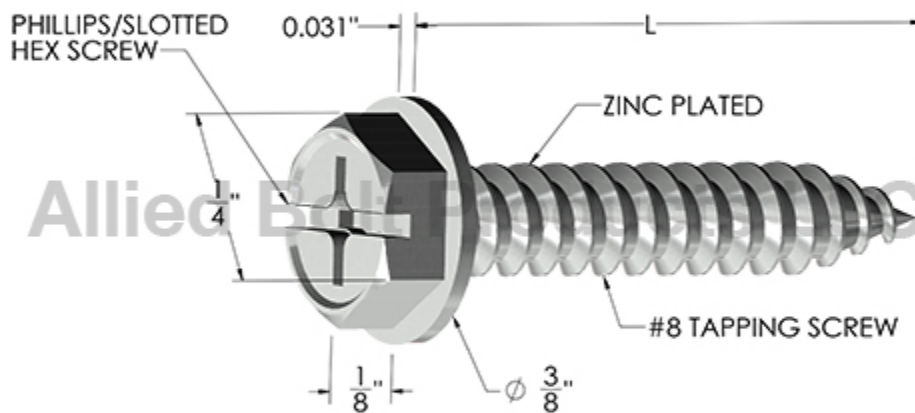
