**3/4" X 4" CONCRETE BOLT**

**#7352**

- Used for attaching heavy loads to concrete, brick, and hollow block.
- Can be removed for adjustment, then re-driven into same hole.
- The Concrete Bolt is designed to match standard fixture clearance holes that are 1/16" over anchor diameter to provide a secure fit.
- Hex size is 1-1/8".
- The washer diameter is 1-13/32".
- Thread length is 3-3/4".
- Minimum Embedment is 3-3/4".
- Can be installed at shallower embedment depths than wedge or sleeve anchors reducing the chance of striking reinforcing bars or embedded cables.
- Utilizes a specially designed relief thread formed in the body of the anchor which allows easy tightening at a reduced torque level and provides dust relief to prevent anchor from jamming.
- A chamfered end easily centers anchor, and a 30° helix angle allows anchor to be tightened quickly. The controlled "screw-in" method is safer than using a hammer.
- Diameter and length appear on the head of each anchor.
- Zinc plated to meet ASTM Specification F1941.
- Manufactured from AISI 1038 heat-treated steel.

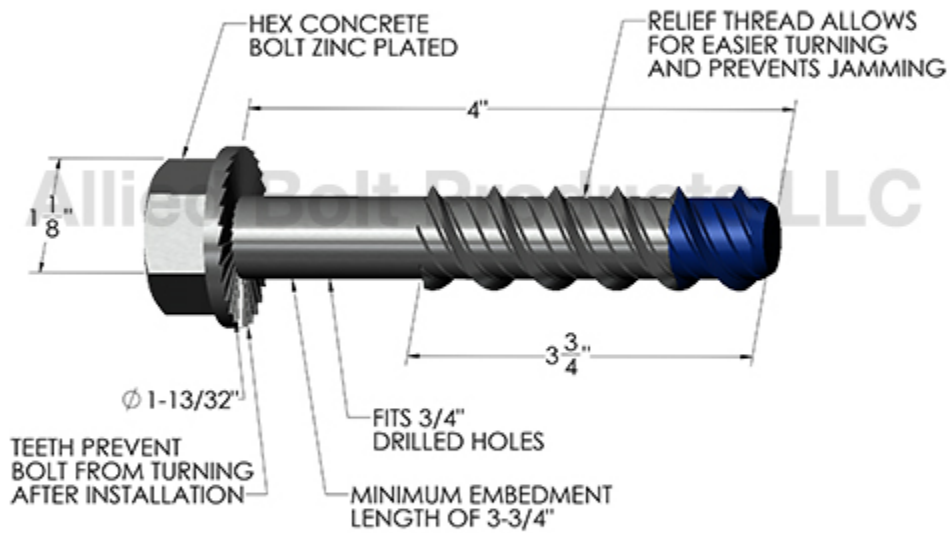
