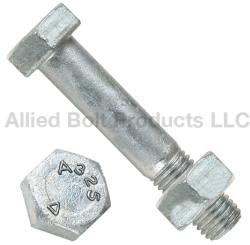

- Nuts conform to the dimensions of ASME B18.2.6.

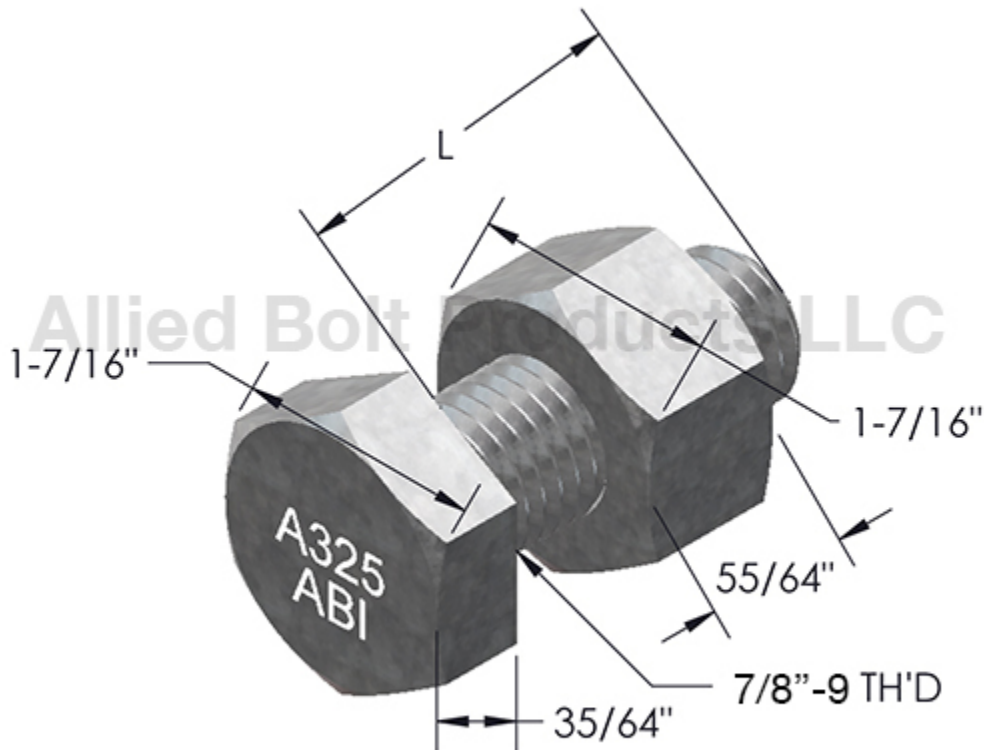
