- Formed from AISI 1020 Steel.
- Hot dip galvanized to meet ASTM Specification F2329.

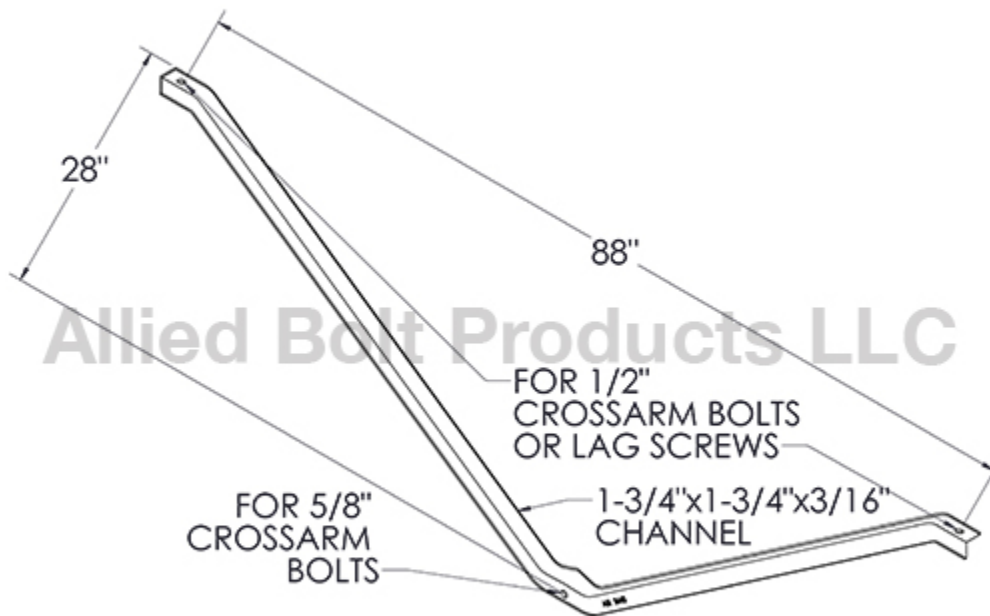
