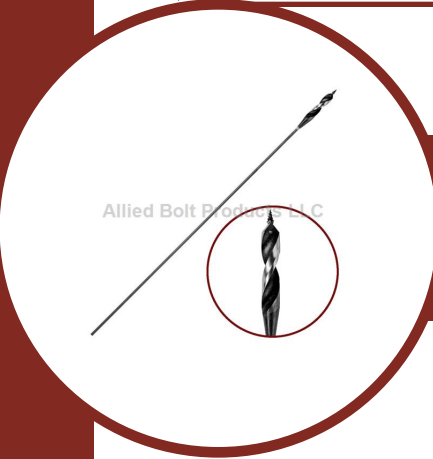

**1/2" X 54" ELECTRICIAN'S STRETCH BIT**

**#89102**

- Used for boring holes through studs within wall cavities and then "snaking" wire from either direction.
- Used with rotation only machines equipped with a three jaw Jacobs type chuck.
- Stretch Bits feature a flexible shaft to allow easy manipulation.
- Stretch Bits have an Auger type configuration with a self-feeding screw point and a long twist for fast chip removal.
- Bits have a hole at the both the tip and the top of the shank so wires can be snaked in either direction.
- The insulated steering guide helps steer the bit while it is hidden inside the wall cavity.
