- Zinc plated to meet ASTM Specification F1941.

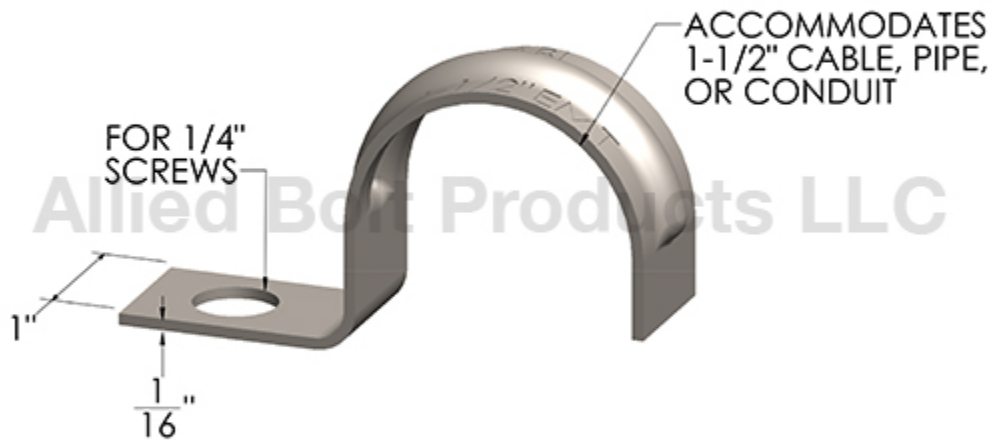
