- Excellent for securing drop cables of concrete and fiberglass poles where drilling holes is difficult.

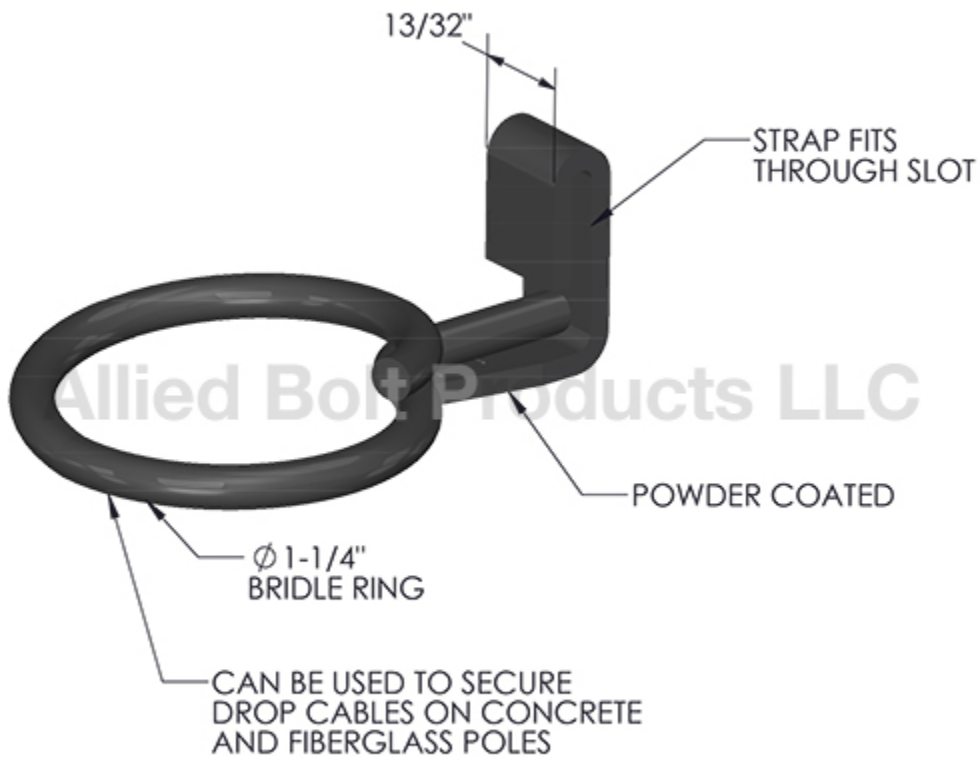
