**3/16" X 1-1/2" C PLASTIC ANCHOR
(MUSHROOM HEAD)**

- Used for making medium weight (under 100 lbs.) attachments such as clamps to all types of masonry.
- Comprised of a nylon body and a steel nail with a slotted head.
- Nails have a threaded shank and slotted head to aid in removal.
- Hole size is 3/16".
- Anchors have a mushroom head body.
- Two longitudinal slots are formed on the working end of anchor to allow each half of the body to expand.
- Nails are manufactured from AISI 1008 Steel.
- Nails are zinc-plated to meet ASTM Specification F1941.
- Not recommended in overhead applications.

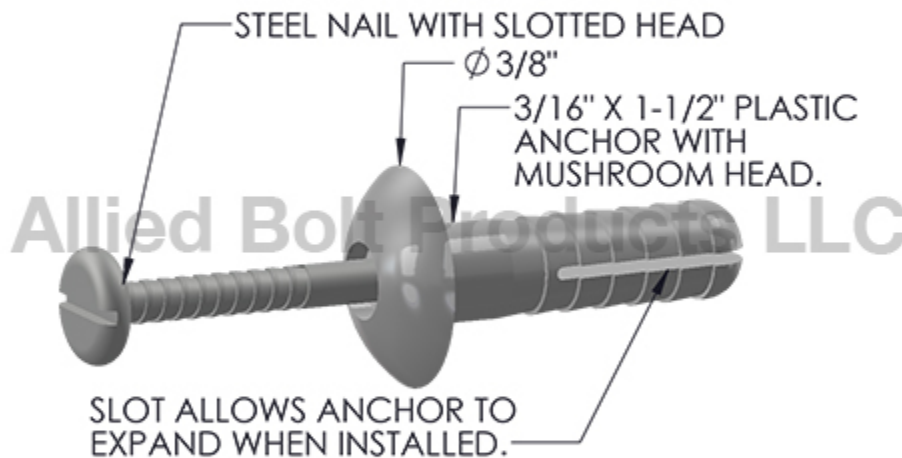
