C SPAN CLAMP

- Used in drop cable installations as an attachment to the strand for either accepting the bail of drop wire clamps, or for wrapping the support wire of drop cable.
- Consists of high strength Aluminum jaws, and a specially shaped bolt with square nut.
- Jaws are extruded from 6063-T6 aluminum.
- Bolt and nut are formed from Grade 2 steel.
- Bolt and nut are hot dip galvanized to meet ASTM Specification A153.
- Bolt is 3/8" diameter for additional strength.
- Attaches to strand sizes ranging from 1/4" (6.6M) to 3/8" (10M).

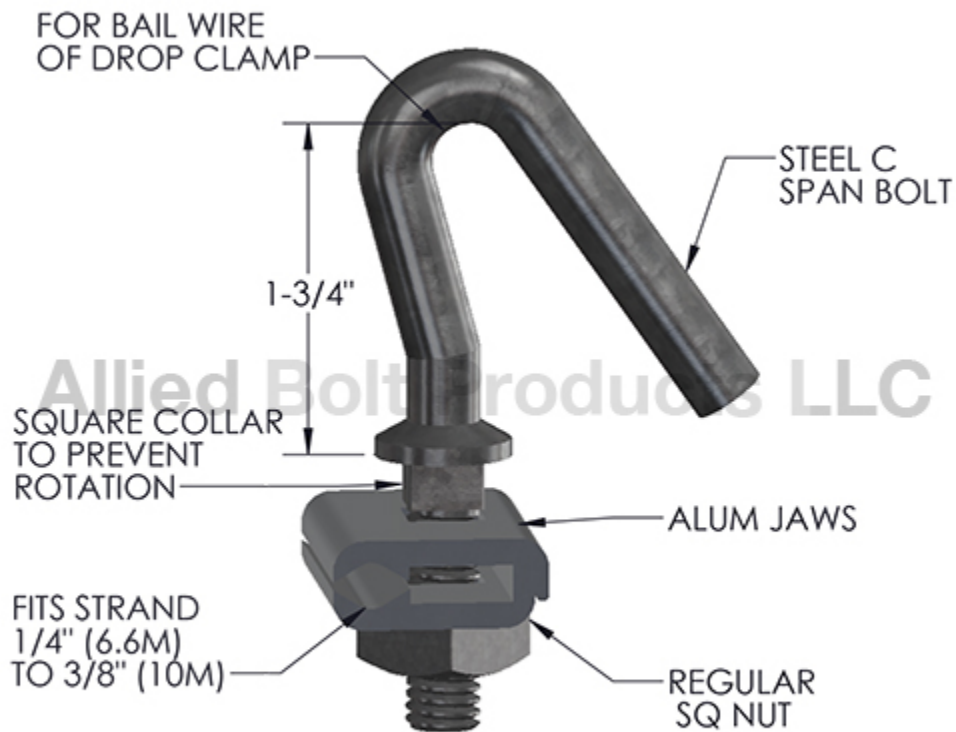
