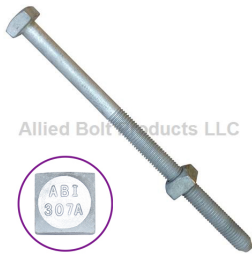

- Has a formed "cone point" to ease attachment of nut.
- Allied Bolt marking (ABI) appears on the head of each bolt.
- Hot dip galvanized to meet ASTM Specification F2329.
- Supplied with attached square nut.
- Minimum tensile strength: 13,550 lbf.
- Recommended torque value: 73 ft lb.
- Minimum thread length is 6".
- Material conforms to ASTM specification A307.
- Dimensions conform to ASME B18.2.1.

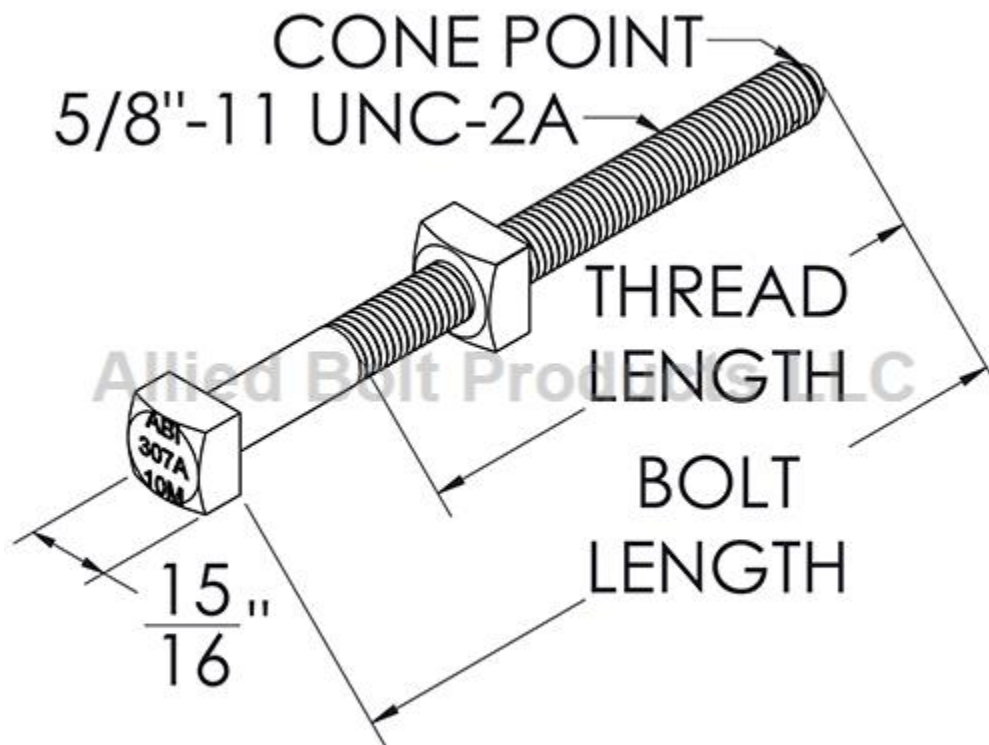
